<b>Row 1</b> <b>Developing a Program with a Purpose</b>	<b>VIDEO &amp; RESPONSE 2A</b>	<ul style="list-style-type: none"> <li>The video demonstrates the running of at least one feature of the program submitted.</li> </ul> <p style="text-align: center;"><b>AND</b></p> <ul style="list-style-type: none"> <li>The response (audio narration or written response) identifies the purpose of the program (what the program is attempting to do).</li> </ul>	<ul style="list-style-type: none"> <li>Response earns the point if it explains the function of the program instead of identifying the purpose.</li> <li>Response earns the point if the illustrated feature runs, even if it does not function as intended.</li> <li>Response earns the point if the response is included in the video via narration or some form of closed captioning and addresses the purpose or function of the program.</li> </ul> <p><b>Do NOT award a point if any one of the following is true:</b></p> <ul style="list-style-type: none"> <li>a video is not submitted; or</li> <li>the video does not illustrate the feature mentioned in the response; or</li> <li>the video does not illustrate the running of the feature (screen shots or storyboards are not acceptable and would not be credited).</li> </ul>	<ul style="list-style-type: none"> <li>Purpose means the intended goal or objective of the program.</li> <li>Function means how the program works.</li> </ul>
<b>Row 2</b> <b>Developing a Program with a Purpose</b>	<b>RESPONSE 2B</b>	<ul style="list-style-type: none"> <li>Describes or outlines steps used in the incremental and iterative development process to create the entire program.</li> </ul>	<p><b>Do NOT award a point if any one of the following is true:</b></p> <ul style="list-style-type: none"> <li>the response only includes the process for determining the program idea and does not address the development process used to create the entire program; or</li> <li>the response does not indicate iterative development; or</li> <li>refinement and revision are not connected to feedback, testing, or reflection; or</li> <li>the response only describes the development at two specific points in time.</li> </ul>	<ul style="list-style-type: none"> <li>Development processes are iterative and cyclical in nature and require students to reflect AND improve on what they have created. Examples of iterative development could include reflection, revision, testing and refining, and improvements based on feedback.</li> <li>The incremental and iterative development process does not need to be a formal method such as waterfall, top-down, bottom-up, agile, etc.</li> </ul>

ARTIFACT</b>	<p>The computational artifact:</p> <ul style="list-style-type: none"> <li>• Identifies the computing innovation.</li> </ul> <p style="text-align: center;"><b>AND</b></p> <ul style="list-style-type: none"> <li>• Provides an illustration, representation, or explanation of the computing innovation’s intended purpose, function, or effect.</li> </ul>	<p>The written response can be used to aid the understanding of how the computational artifact illustrates, represents, or explains the computing innovation’s intended purpose, function, or effect.</p> <p><b>Do NOT award a point if any one of the following is true:</b></p> <ul style="list-style-type: none"> <li>• there is no artifact; or</li> <li>• the artifact is not a computational artifact; or</li> <li>• the innovation identified in the artifact does not match the innovation described in the written response; or</li> <li>• the artifact does not identify the innovation clearly; or</li> <li>• the artifact does not illustrate, represent or explain the innovation’s intended purpose, function, or effect; or</li> <li>• the artifact illustrates a feature of the innovation instead of the purpose, function, or effect; or</li> <li>• the computational artifact doesn’t clearly illustrate, represent, or explain as required in the scoring criteria AND the written response describes the innovation’s intended purpose and function without explaining how the computational artifact illustrates, represents, or explains the intended purpose, function, or effect.</li> </ul>	<ul style="list-style-type: none"> <li>• A computational artifact is something created by a human using a computer and can be, but is not limited to, a program, an image, an audio, a video, a presentation, or a web page file. The computational artifact could solve a problem, show creative expression, or provide a viewer with new insight or knowledge.</li> <li>• A computing innovation is an innovation that includes a computer or program code as an integral part of its functionality.</li> </ul>
<b>Row 2</b> <b>Analyzing Impact of Computing</b>	<b>RESPONSE 2A</b>	<ul style="list-style-type: none"> <li>• States a fact about the correctly identified computing innovation’s intended purpose <b>OR</b> function.</li> </ul>	<p><b>Do NOT award a point if:</b></p> <ul style="list-style-type: none"> <li>• the identified innovation is not a computing innovation; or</li> <li>• the written statement gives an effect (which is required for the scoring criteria in Row 3, not Row 2).</li> </ul>	<ul style="list-style-type: none"> <li>• A computing innovation is an innovation that includes a computer or program code as an integral part of its functionality.</li> <li>• Computing innovations may be physical computing innovations such as Google glasses or self-driving cars, non-physical computer software like a cell phone app, or computing concepts such as e-commerce or social networking which rely on physical transactions conducted on the Internet.</li> <li>• Purpose means the intended goal or objective of the innovation.</li> <li>• Function means how the innovation works (e.g., consumes and produces data).</li> </ul>

Groups or individuals can be used to represent society. Examples of effects include but are not limited to:               <ul style="list-style-type: none"> <li>○ The innovation and impact of social media online access varies in different countries and in different socioeconomic groups. (EK 7.4.1A)</li> <li>○ Mobile, wireless, and networked computing have an impact on innovation throughout the world. <b>Row 6</b> <b>Analyzing Data and Information</b>	<b>RESPONSE 2D</b>	<ul style="list-style-type: none"> <li>Identifies the data that the identified or described computing innovation uses.</li> </ul> <p style="text-align: center;"><b>AND</b></p> <ul style="list-style-type: none"> <li>Explains how that data is consumed, produced, <b>OR</b> transformed.</li> </ul>	<p>Responses should be evaluated on the rationale provided in the response not on the interpretation or inference on the part of the scorer.</p> <p><b>Do NOT award a point if any one of the following is true:</b></p> <ul style="list-style-type: none"> <li>the described innovation is not a computing innovation; or</li> <li>the response does not state the specific name of the data or simply says “data”; or</li> <li>the response confuses or conflates the innovation with the data: response fails to explain what happens to the data; or</li> <li>the response confuses the source of the data with the data.</li> </ul>	<ul style="list-style-type: none"> <li>Data types include: integers, numbers, Booleans, text, image, video, audio, signals. Data that infer these types like fingerprints, temperature, music, length, pictures, etc. are allowed.</li> <li>Data collection devices (e.g., sensors, cameras, etc.) are not data.</li> <li>Large data sets include data such as transactions, measurements, texts, sounds, images, and videos. The in-text citations may be oral in the computational artifact.</p> <p><b>Do NOT award a point if any one of the following is true:</b></p> <ul style="list-style-type: none"> <li>the response contains a list of sources only, no in-text citations; or</li> <li>the response contains less than three in-text citations; or</li> <li>there are not three in-text citations with corresponding references.</li> </ul>	<ul style="list-style-type: none"> <li>In-text citations may be provided in any way that acknowledges the source: <ul style="list-style-type: none"> <li>○ According to...” or “As written in the New York Times...”</li> <li>○ Parenthetical</li> <li>○ Footnotes</li> <li>○ Numerical superscripts with corresponding footnote</li> <li>○ Number system with a corresponding reference</li> </ul> </li> </ul>
