

### **Score Rationale**

This portfolio has written evidence of practice, "going out and getting different pictures with different colors, shades, and lighting." However, visual evidence does not support the statement. In image 2, there is little investigation of colors, shading, and lighting, as can be seen with the simple application of paint in the flowers. Although the written evidence in image 9 mentions that the photograph's setting is at a Japanese restaurant with an emphasis on the different colors and shade values, the image contains little color and has limited values. Furthermore, in image 12, there was an "Emphasis on a different number of things," which lacks the specificity of the design idea and does not connect to the sustained investigation. Overall, the visual evidence of practice, experimentation, or revision does not relate to a sustained investigation and could use more development.
