### **Score Rationale**

This portfolio focuses on the relationship between humans and birds and shows visual and written evidence of practice and experimentation relating to the sustained investigation. Almost all images show multiple compositions, with two vertical blocks on the left and one smaller block on the right. The practice of collage using photographs, magazine cutouts, and digital editing is also the same across the portfolio.

In image 1, a self-portrait is the main focus of the composition. Through three images, the revisions of color from an analogous palette to monochrome are observable, and the images' placement uses proportion, scale, and space to activate the picture plane. In image 9, a triangular arrangement demonstrates some experimentation with composition, but the color shifts are awkward and not cohesive.

Some works do not demonstrate the sufficient transformation of borrowed images, which hinders composition development. For example, in image 14, a photograph of the artist Prince cited as an image taken from a magazine, does not successfully demonstrate substantial, significant, and transformative development through materials, processes, and ideas inherent to the AP Art and Design Artistic Integrity Agreement.

Across the works in this portfolio, the figures do not appear manipulated or revised significantly, and color shifts are limited, repetitious, and do not evoke experimentation. Overall, this portfolio shows evidence of practice but does not advance the sustained investigation through experimentation and revision, so it remained at a score of two.

I explored the connections between US presidents (3-6), musicians (12-15), writers (7, 8), athlete (10,11) and actress (9) with their pet birds. I cleaned and finalized my images using Adobe (1, 3-15).
