Response:

As you walk through a field, forest, or meadow, it is easy to miss the magic of the microscopic organisms that keep this world beautiful. There would not be any pretty flowers or expansive trees without the many insects that work to pollinate them. I decided to conduct an investigation in the lives of honeybees and their complex social lives in the hive. Additionally, while working on this investigation, the hive I was photographing died which added a somber tone to some of my pieces, but also gave me a much clearer view into the fragility of pollinators and the ecosystems that rely on them.

Describe ways your sustained investigation developed through practice, experimentation, and revision.

Response:

My portfolio displays a wealth of experimentation, revision, and honing of the skills needed to take such detailed photos at the scale these insects live at. For each final picture, I had to re-shoot the scene many times. This often meant losing out on opportunities for interesting images as the subjects in these scenes change from one second to another. Throughout my investigation, I was forced to work around the very challenging parameters that come with shooting at this scale. I also learned many new post production editing techniques necessary to achieve specific results.



Score Rationale

The written evidence in this portfolio identifies an inquiry, and the visual evidence demonstrates the inquiry "to conduct an investigation into the lives of honeybees and their complex social lives in the hive." Several images throughout the portfolio show pairs or groups of bees in a hive (Images 2 and 12). Other than cropping, there is no manipulation of the subject matter. The images show the bees in different close-up angles (Images 1, 2, 5, 7, 9, 11, and 12); although similar, there is no progression of the inquiry. Written evidence identifying the investigation states, "The hive I was photographing died and added a somber tone to some of my pieces." This experience may have provided an opportunity for further development, but instead, the work relies heavily on repetition, as seen in Images 4, 13, and 14. Because of the repetitive patterns, the inquiry does not explore or lead to discovery. Therefore, the inquiry does not guide the development of the sustained investigation, and thus, the inquiry earned a score of 2.
