#### **Question 1: Concept Application 3** points Α. Describe the implied power of Congress being exercised in the scenario. 1 point Acceptable descriptions include: Congress is reviewing the actions of the bureaucracy. • Congress is using oversight by requesting information from the bureaucracy. The power of oversight is being exercised when Secretary Ross is testifying under oath in front of the House committee. Β. Explain how the media can influence the use of the power described in part A. 1 point Acceptable explanations include: The media informs voters of an issue, who could then urge Congress to investigate the bureaucracy. Congress can learn about the Census's problems through the media and use its oversight powers to resolve them. С. Explain how the chairperson's actions in the scenario might influence someone engaged 1 point in retrospective voting. Acceptable explanations include: The retrospective voter model predicts that voters who approve of Maloney's actions will be more likely to vote for her in the next election. Voters who disagree with Maloney's decision may vote against her in the future, based on the predictions of the retrospective voter model. A citizen may choose to vote for Maloney's party in an upcoming congressional election based on Maloney's behavior. Voters might choose to not vote for the incumbent president because they were dissatisfied with the performance of the Commerce Secretary, who was nominated by the president.

#### **Question 1**

#### Overview

The Concept Application question expected responses to apply course concepts in response to a provided real-world scenario. The focus of the scenario was on a congressional committee hearing in which the Secretary of Commerce, Wilbur Ross, failed to disclose issues with the 2020 census process. The scenario addresses several topics in the course and exam description from Unit 2 and Unit 5 that relate to Congress holding the federal bureaucracy accountable, the role of the media as an agenda setter, and models of voting behavior.

In part A responses were expected to describe the implied power of Congress to oversee bureaucratic agencies. The focus in part A was for responses to use the information in the scenario to demonstrate that Congress/the House Committee on Oversight and Reform/Chairperson Maloney were holding Secretary of Commerce Wilbur Ross accountable through their oversight power for the poor execution of the 2020 census. Some responses just identified checks and balances as an implied power without sufficiently demonstrating oversight within the context of that particular check on the bureaucracy.

In part B responses were expected to explain how the media's investigations could influence congressional oversight, either by describing how the media can raise awareness and activate public pressure, or by directly influencing Chairperson Maloney's decision to act.

In part C responses were expected to explain how someone engaged in retrospective voting would change their vote based on Chairperson Maloney's actions from the scenario, either by recognizing her/her actions on behalf of the party and either voting or not voting for her in future elections, or by not voting for the president who appointed Secretary Ross in future elections.

#### Sample: 1A Score: 3

The response earned 1 point in part A. The response states "to hold Congressional oversight hearings as a way to check the power of the bureaucratic agencies," which is an acceptable description of the implied power of Congress being exercised in the scenario.

The response earned 1 point in part B. The response states "if Congress is made aware of issues through the media, they will likely take that knowledge and issue an oversight hearing to address the issues" which sufficiently explains how the media can influence the use of the power in part A.

The response earned 1 point in part C. The response states "The actions taken by the chair person may show a retrospective voter that the candidate is/was unreliable and not transparent. This may cause the retrospective voter to not vote for the candidate in the future running due to past failures," which sufficiently explains how the chairperson's actions in the scenario might influence someone engaged in retrospective voting.

#### **Question 1 (continued)**

#### Sample: 1B Score: 2

The response earned 1 point in part A. The response "allows Congress to overlook the Bureaucracy's actions" is an acceptable description of the implied power of Congress being exercised in the scenario.

The response earned 1 point in part B. The response explains that "many agencies actions are easily exposed through the media ... From the exposure of the media, Congress ... is increasing the use of congressional oversight to correct these actions." The response accurately demonstrates how media influences the use of the power described in part A.

The response earned 0 points in part C. Even though the response says "Someone engaged in retrospective voting means that they look upon a persons past actions in their role to decide whether to re-elect or not elect them for that role," this does not accurately explain how the chairperson's actions in the scenario might influence someone involved in retrospective voting.

#### Sample: 1C Score: 1

The response earned 0 points in part A. The response "the power to coin money," is not an implied power of Congress being exercised in the scenario.

The response earned 0 points in part B. Even though the response states "Media can ... inform the public on problems with congress," coining money is not an implied power being exercised in the scenario.

The response earned 1 point in part C. The response states "the voter will think back in the past at what has this chairperson has done that might gain their vote." This is a sufficient explanation because it references how the chairperson's actions in the scenario might influence someone engaged in retrospective voting.
