
First person stage p.o.v with fan light sticks in the audience.

Scoring Criteria

Writing

Written evidence may identify materials, processes, and ideas.

Drawing Skills

Visual evidence of **rudimentary** Drawing skills.

Materials, Processes, and Ideas

Little to no evidence of **visual relationships** among materials, processes, or ideas.

Score Rationale

The written evidence may identify materials, processes, and ideas, but lacks a thorough explanation of intention and purpose. For instance, the idea in Work 3, "Lotus flower with music notes drifting on water" would benefit from more clarification.

The works presented in this portfolio exhibit rudimentary Drawing skills. Using digital drawing techniques, Works 2 and 5 demonstrate an emerging application of markmaking, line, and light and shade using a digital art pen. In Works 1, 3, and 4, there is little evidence of an understanding of space, leading to compositions not fully resolved. In all five works, the figure-ground relationships are undeveloped. Overall, there is visual evidence of rudimentary Drawing skills in this portfolio.

There are attempts at establishing visual relationships between the materials, processes, and ideas. For example, in Work 1, the use of directional mark-making reinforces the ideas stated in the written evidence "fan light sticks in the audience" and the processes of "using thin brushes and sponges to create light." However, Work 3 shows little evidence of the connection between ideas and processes as depicted through the "Lotus flower with music notes drifting on water." Furthermore, the "Memory of a beloved dog" in Work 4 provides little to no evidence of relationships among materials, processes, or ideas because the idea of memory is not present.
