

THE AP WITH WE SERVICE LEARNING SCHOLARSHIP CONTEST

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. Void where prohibited by law. This Contest (defined below) is subject to all federal, state, and local laws, regulations, and ordinances.

The AP with WE Service Learning Scholarship Contest ("Contest") starts on December 20, 2019 at 12:00:01 a.m. Eastern Standard Time ("EST") and ends on June 30, 2020, at 11:59: 59 p.m. EST. College Board's computer is the official timekeeping device for this Contest.

By participating, each entrant (and, if a minor, their parent or legal guardian) agrees to abide by these Official Rules and decisions of the College Board, The Allstate Foundation and WE (collectively, "Sponsors") and judges, which shall be final and binding in all respects relating to this Contest.

1. CONTEST OVERVIEW.

The AP with WE Service Scholarship Contest, made possible by The Allstate Foundation, was created to recognize students for the completion of their service learning projects for AP with WE Service and reward exceptional students who have made a positive impact on their local and global communities.

The Contest is open to students or student groups who are enrolled in AP with WE Service and meet all eligibility requirements stated below.

Two (2) contest winners will each receive \$50,000 scholarships. A winner may be a student or a student group, and in case of a student group, scholarship will be split evenly among all qualified members of that group.

2. ELIGIBILITY.

The Contest is open to students or student groups ("Entrants") who meet the following eligibility requirements:

- They attend a public or private high school located in one of the 50 United States, the District of Columbia, Puerto Rico, the U.S. Virgin Islands, Guam, American Samoa, the Northern Mariana Islands, or any other U.S. territory or possession.
- They are enrolled in AP with WE Service, are scored in the AP Digital Portfolio, and earn the AP with WE Service Recognition on their score reports (in case of a student group Entrant, at least one student in the group must earn the AP with WE Service Recognition and only the students who earn the AP with WE Service Recognition may receive the scholarship).
- Nominated by AP with WE Service designated teacher ("Submitting Teacher").
- Children or wards of (i) employees, officers and trustees of each Sponsor, and its respective affiliates and (ii) employees and officers of the scholarship's advertising and promotion agencies, if any, as well as the children and wards of household members of (i) and (ii), whether or not related, are not eligible to receive this scholarship.

3. **HOW TO ENTER.**

Submitting Teachers must submit application online by following this [Contest Link](#) (an “Entry”) by 11:59: 59 p.m. EST on June 30, 2020. All submissions must be made on behalf of the Entrants by Submitting Teachers.

Application Requirements:

1) Student Essays

- Entrants (if a student group, writing as a group) must submit essays responding to each of the following prompts:
 - Describe your service learning project and how it enhanced your understanding of the AP course content and skills. (maximum 250 words)
 - Describe the impact your service learning project has had on your local and/or global community. (maximum 250 words)
- Entrants (if a student group, each student in the group) must submit an essay responding to each of the following prompts:
 - Describe and explain the impact the service learning project has had on the development of your leadership and communication skills, analytical ability, and understanding of civic responsibility. (maximum 200 words)
 - Explain your college aspirations and how this scholarship will help you achieve these goals (maximum 200 words)

2) **Submitting Teacher Essays**

- Submitting Teachers must submit essays responding to the following prompts:
 - Why did you select this student or group and what developments and growth have you observed in them by participating in AP with WE Service?
- Submitting Teachers may respond to additional optional essay prompt:
 - Explain how AP with WE Service enhanced course content and skills through service learning.

3) Consent and Release - In case of a student group Entrant, students may, but are not required to, execute a Consent and Release, provided that at least one participating qualified student in the student group Entrant agrees to be recognized on behalf of such student group and execute and return a Consent and Release.

4) **AP with We Service enrollment**

- Entrants must be scored in the AP Digital Portfolio
- Entrants must earn the AP with WE Service Recognition on the score reports (in case of a student group Entrant, at least one student in the group must earn the AP with WE Service Recognition and only the students who earn the AP with WE Service Recognition may receive the scholarship)

Limit one (1) Entry per Submitting Teacher per AP with WE Service subject. If a teacher teaches multiple classes on an AP with We subject, they may submit no more than one Entry for such AP with WE subject. However, if a teacher teaches more than one AP with WE subject, they may submit one Entry per subject. If a class is co-taught by multiple teachers, only one Entry for such class but if more than one teacher within a school teaches the same AP with WE Service subject, they may each submit an Entry. Entries received in excess of the foregoing limitations will be void. All Entries become the sole property of the Sponsors and will not be returned.

Each Submitting Teacher by submitting an Entry, and each Entrant (and, if a minor, their parent or legal guardian) by participating in the Contest, represents and warrants that the Entry conforms to these Official Rules and understands that Sponsors, in their sole discretion, may disqualify the Entry for any reason, including if they determine, in their sole discretion, that the Entry fails to conform to these Official Rules in any way or otherwise contains unacceptable content.

4. PRIZES.

Two (2) \$50,000 scholarships (if an Entrant is a student group, to be split evenly among all eligible members of such student group). All federal, state, and local taxes, if applicable, are the sole responsibility of the Winners (defined below). Winner may not substitute, assign or transfer a prize, but Sponsors reserve the right, at their sole discretion, to substitute a prize of comparable or greater value. All prize details are at Sponsors' sole discretion. Limit one (1) prize per person. If a student is an individual Entrant as well as a member of a student group Entrant, and both Entries win the prizes, they may only claim the prize as the individual Entrant. The prize awarded to the student group Winner will be equally divided amongst the participating eligible student (excluding such student) in the group.

5. SELECTION OF WINNERS.

All eligible Entries received by College Board will be judged by a panel of qualified judges who are members of College Board Advanced Placement®, The Allstate Foundation and WE based on the submitted essays including their evidence and commentary, thoroughness and sophistication and overall project impact (collectively, "Judging Criteria"). Two (2) winners will be selected from among all eligible Entries received. In the event of a tie for a prize, an additional, "tie-breaking" judge will determine the winner based on the Judging Criteria. Sponsors reserves the right not to award a prize if, in their sole discretion, College Board does not receive a sufficient number of eligible and qualified Entries. All decisions of the Sponsors and judges are final and binding. Sponsors will not reveal the judging scores for any Entry.

6. NOTIFICATION OF WINNERS.

If selected as potential winners, Submitting Teachers and Entrants (in case of a student group, each eligible student in the group) will be notified by email by July 31, 2020 with a request to have each Entrant (and, if a minor, their parent or legal guardian) execute and return an Affidavit of Eligibility and Liability and other documentation ("Requested Documentation"), including a Publicity Release within sixty (60) days of the date of notification. Potential winners must execute and return the Requested Documentation to claim their prize. In case of a student group Entrant, students may, but are not required to, execute a Publicity Release, provided that at least one participating qualified student in the student group Entrant agrees to be recognized on behalf of such student group and execute and return a Publicity Release.

Return of notification as undeliverable, failure to provide, sign and return Requested Documentation within the specified time period, the inability of College Board to contact a potential winner (either the Submitting Teacher or Entrant) within a reasonable time period or noncompliance with these Official Rules will result in disqualification and, at Sponsors' sole discretion, an alternative potential winner may be selected in accordance with the Judging Criteria described above.

7. DISBURSEMENT.

Students selected to receive scholarship funds ("Winners") must indicate a Title IV accredited institution of higher education, including accredited two-year, four-year and for-profit ("Institution") for disbursement by College Board. Winner must indicate the Institution to College Board at least 30 calendar days before the

beginning of their first semester at the Institution as indicated by Institution. College Board will never disburse scholarship funds or monies directly to Winner; it will disburse scholarship funds only to Institutions. In cases where, prior to full disbursement, a Winner (i) changes or transfers to a new Institution, (ii) defers enrollment, or (iii) ceases attending or leave the Institution for any reason, the Winner shall promptly notify College Board of such change in their enrollment at the Institution, which shall be no later than five (5) business days after such change has been notified to the applicable Institution. Upon receipt of notification, in case of (i), College Board shall disburse any remaining scholarship funds to the new Institution provided it is a Title IV eligible institution; and in case of (ii) and (iii), Winner shall have 12 months (or 36 months in the case the reason for such deferral or leave is to enroll in the military) to notify College Board of their enrollment at a new Title IV eligible Institution (together with a reasonable proof of such enrollment and, in the case of a military-related deferral or leave, documentation of the applicable military service) or the Winner will forfeit the remainder of the scholarship. College Board may use a third party vendor for the disbursement and associated administrative support.

8. VERIFICATION OF WINNERS.

ALL POTENTIAL WINNERS ARE SUBJECT TO VERIFICATION BY SPONSORS, WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. A ENTRANT IS NOT A WINNER UNLESS AND UNTIL ENTRANT'S ELIGIBILITY HAS BEEN VERIFIED AND ENTRANT HAS BEEN NOTIFIED THAT VERIFICATION IS COMPLETE.

9. PUBLICITY GRANT.

Except where prohibited by law, participation in the Contest constitutes each Submitting Teacher and Entrant's (and a minor entrant's parents' and legal guardians') consent to Sponsors' (and its designees', successors' and assigns') use or distribution of such Submitting Teacher's or Entrant's, as applicable, name, likeness, voice, photographs, video, opinions, statements, hometown, state and country of residence, high school, school district, participating AP subject(s) and entry for promotional, advertising, research and other purposes (including in communicating with their school and school district regarding entry and potential or actual receipt of scholarship funds) in any manner or media (including, without limitation, online, on websites and in social media), worldwide, in perpetuity, and without further payment, consideration, notice, review or consent.

10. RELEASE OF LIABILITY.

By participating, each Submitting Teacher and Entrant (in case of a student group Entrant, each member of such student group) and, if a minor, their parent or legal guardian, agrees to release, discharge, and hold harmless each Sponsor (and advertising and promotion agencies), and the respective officers, directors, shareholders, employees, agents, and representatives of the forgoing (collectively, "Released Parties") from any and all injuries, liability, losses, and damages of any kind to persons, including death, or property resulting, in whole or in part, directly or indirectly, from Participating Teacher's or Entrant (or member of such student group Entrant)'s, respectively, participation in the Contest or any Contest-related activity or the acceptance, possession, use, or misuse of any awarded prize.

Persons who tamper with or abuse any aspect of the Contest, who act in an unsportsmanlike or disruptive manner, or who are in violation of these Official Rules, as solely determined by Sponsors, will be disqualified and all associated entries will be void. Should any portion of the Contest be, in Sponsors' sole opinion, compromised by non-authorized human intervention or other causes which, in the sole opinion of the Sponsors, corrupt or impair the administration, security, fairness or proper play, or submission of entries, Sponsors reserves the right, at its sole discretion, to suspend, modify, or terminate the Contest and, if

terminated, at its discretion, award the prizes from among all non-suspect, eligible entries received up to time of such action using the judging procedure outlined above or as otherwise deemed fair and appropriate by Sponsors. CAUTION: ANY ATTEMPT DELIBERATELY TO DAMAGE OR UNDERMINE THE LEGITIMATE OPERATION OF THE CONTEST MAY BE IN VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSORS RESERVES THE RIGHT TO SEEK DAMAGES AND OTHER REMEDIES (INCLUDING ATTORNEYS' FEES) FROM ANY SUCH INDIVIDUAL TO THE FULLEST EXTENT OF THE LAW, INCLUDING CRIMINAL PROSECUTION.

11. DISPUTES.

Except where prohibited, each Submitting Teacher and Entrant (in case of a student group Entrant, each member of such student group) and, if a minor, their parent or legal guardian, agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Contest or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the District of New York or the appropriate State Court located in New York; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsors in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the State of New York, without giving effect to any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than the State of New York.
