#### **Question 4: Contextual Analysis**

(A) Accurately describes the materials OR techniques used to create the *Bayeux Tapestry*. 1 point Examples of acceptable responses include the following: The Bayeux Tapestry is comprised of linen cloth and wool yarn. The cloth is embroidered or stitched with wool yarn dyed in eight different colors. • The woven cloth is cut and sewn into a long, horizontal wall hanging. (B) Accurately describes ONE historical event depicted in the *Bayeux Tapestry*. 1 point Examples of acceptable responses include the following: Harold of Wessex swears an oath to support William, Duke of Normandy (also known as William the Conqueror). Harold breaks the oath to William and has himself crowned as the king of England after the death of Edward the Confessor. Upon hearing of Harold's betrayal, William and his half-brother Bishop Odo make battle preparations to invade England. After arriving on the south coast of England, the Normans defeat the English in the Battle of Hastings of 1066; Harold is killed in the combat. • William becomes King of England. (William's coronation may have been depicted in the missing last section of the embroidery.) 1 point Accurately uses specific evidence to explain ONE example of how a political point of view is (C) shown through the depiction of the events. Examples of acceptable responses include the following: The embroidery functions as a work of propaganda by presenting details of the Battle of Hastings from the perspective of the Norman victors. The embroidery emphasizes William's leadership, ingenuity, and even generosity, through his strategic planning and extensive preparation for battle. The embroidery favorably distinguishes the Normans from the English by highlighting how the Norman cavalry dominated the Anglo-Saxon foot soldiers. The depiction of a star (thought by scholars to have been Halley's Comet) could be read as an omen or sign of divine disapproval of Harold's usurpation of the throne and the breaking of his oath. In addition to identifying key figures who play a political role in the drama, the Latin text arguably provides a running narrative from the perspective of the victors. Images in the margins on the top and bottom of the piece could be interpreted as having meaning that informs the main narrative in the center of the work or bolsters the victors' point of view. The depiction of a banquet could be interpreted as conveying a political point of view in the context of preparing for battle or in depicting feudal hierarchies.

  Examples of acceptable responses include the following:

   By depicting the narrative from a Norman point of view, the patron of the *Bayeux Tapestry* sought to validate William's right to rule as king, by suggesting that he was divinely approved and thoroughly qualified to rule England.
   Most agree that the patron was William's favor by depicting the events from a perspective that represented the Norman conquest of England in a positive light.
  - In the embroidery, Bishop Odo is identified multiple times by name and portrayed as a loyal participant in the Norman campaign, thereby highlighting his role in the events that led to William's coronation as King of England.
  - The long, portable embroidery was likely meant to be hung in a vast interior space, such as that of a cathedral or great hall, providing large audiences with an impressive and propagandistic visual narrative of the Norman victory.

### **Question 4**

#### Overview

Responses were supposed to demonstrate primarily the art historical thinking skill of contextual analysis, applied to a work from the Course and Exam Description (CED). To be awarded all five score points, the response needed to successfully accomplish the following tasks:

- Describe the materials or techniques used to create the *Bayeux Tapestry*.
- Place the *Bayeux Tapestry* in its historical and political context by describing a historical event depicted in the work and explaining how a political point of view is shown through the depiction of historical events.
- Address the role of patronage in the *Bayeux Tapestry* by explaining how the patron's point of view is reflected in the work.

# Task A: Accurately describes the materials OR techniques used to create the *Bayeux Tapestry*. (1 point)

The response earned this point by stating that the tapestry is made out of "embroidery on linen."

#### Task B: Accurately describes ONE historical event depicted in the Bayeux Tapestry. (1 point)

The response earned this point by identifying the historical event as the "Norman conquest of England under William I."

# Task C: Accurately uses specific evidence to explain ONE example of how a political point of view is shown through the depiction of the events. (1 point)

The response earned this point through the evidence that the work expresses a political point of view by suggesting that God is on the side of the Normans, evidenced by Bishop Odo blessing the meal.

# Task D: Accurately uses specific evidence to explain ANOTHER example of how a political point of view is shown through the depiction of the events. (1 point)

The response earned this point through the evidence that the work also expresses a political point of view by fully describing how "the Norman troops were superior and thus able to prevail."

#### Task E: Accurately explains how the Bayeux Tapestry reflects the point of view of its patron. (1 point)

The response earned this point by stating that the patron was likely a Norman who supported William's conquest through "overall glorification."

# Task A: Accurately describes the materials OR techniques used to create the *Bayeux Tapestry*. (1 point)

The response earned this point by stating that the work was made with "thread on cloth through the process of embroidery."

#### Task B: Accurately describes ONE historical event depicted in the Bayeux Tapestry. (1 point)

The response earned this point by identifying the historical event in which "William the Conqueror came out successful." Although England at this time should not be referred to as Britain, the response gets around that by saying "what is known today as Britain," and the mention of William does qualify the statement as a reference to an actual historical event.

### Task C: Accurately uses specific evidence to explain ONE example of how a political point of view is shown through the depiction of the events. (1 point)

The response earned this point by distinguishing the two armies, describing one as "superior" because "they are on horses and their enemies are not."

# Task D: Accurately uses specific evidence to explain ANOTHER example of how a political point of view is shown through the depiction of the events. (1 point)

This point was earned for distinguishing the two armies by showing the "victor's preparations and celebrations" and only showing those on the losing side "when they are being defeated."

# Task E: Accurately explains how the *Bayeux Tapestry* reflects the point of view of its patron. (0 points)

Although the response includes an attempt to address this task, it restates the glorification of the victors without clearly connecting it to the patron.

The response earned this point by stating that the work was created by "embroidering colored yarn into a piece of cloth."
